CONSENT AGENDA

Consent Agenda:

FINANCE

Resolution 2022-13 Adopt Budget and Tax Levies for 2023 and Approve Limit Factor for Property Tax Levy:

Mr. Brockmann presented Resolution 2022-13 for the District to approve and adopt the District's Budget and Tax levies for the calendar year 2023, and approve the limit factor for the District's regular property tax levy in calendar year 2023. A motion was made, seconded, and unanimously carried to approve Resolution 2022-13.

Resolution 2022-14 Approve Dollar Amount and Percentage Increase in Regular Property Tax Levy:

Mr. Brockmann presented Resolution 2022-14 to approve the dollar amount and percentage increase in the District's regular property tax levy for the calendar year 2023. A motion was made, seconded, and unanimously carried to approve Resolution 2022-14.

District Program Update:

Carol Hawk, Chief Operating Officer, presented an overview of all six Pillars, with an emphasis on current programs that are running. Amy Wilcox, Grant Writer, and Resource Development Lead spoke about grant funding opportunities. The District recently applied for a \$130,000 grant from the Health Care Authority for Opioid Misuse Prevention. Ms. Wilcox also spoke about receiving a contract from Skagit County Public Health of \$14,000 to develop a \$5.8 million grant proposal to the WA Department of Commerce for Behavioral Health Facility. The District will not have an ongoing role in the operation of the facility, but it is supportive of this potential community asset.

PeaceHealth Quality Update:

Mr. Johnston, PeaceHealth's Chief Administrative Officer, had no formal update.
