Job Overview:

The MHFA Instructor will provide trainings to parents/caregivers, educators, and community members during in-person and virtual sessions. MHFA teaches adults how to assist those who are experiencing a mental health or substance use-related crisis by utilizing a five-step action plan centered in hope and recovery.

Responsibilities and Duties:

- Ability to work with and instruct diverse populations.
- Strong presentation and facilitation skills, and the ability to direct adult learners.
- Must utilize the materials for instruction provided by Mental Health First Aid and the National Council for Mental Wellbeing.
- Willingness to prepare before the session to lead effectively.
- Assist with marketing and perform outreach for the program.
- Commitment to teach the program as designed with fidelity.
- Fill out all requested reports and collect participant data.
- Other duties related to the planning, delivery, and wrap up of trainings.

Qualifications:

- High School Diploma or GED required; some college preferred.
- Must be certified in Adult and/or Youth MHFA (training provided).
- Successfully pass a Washington State Patrol Background Screening (or similar agency).
- Bilingual a plus.

Work Conditions:

- General office environment, virtual and community settings.
- Schedule dependent on community need and instructor availability.

Required Physical Abilities:

• Must be physically able to present/instruct a class for extended periods of time, up to 8 hours per day.
