# District Office Remodel (General Contractor Bids & Updated Cost):

Mr. Brockmann gave an update on the District Office remodel project. On August 6, 2024, general contractor bids were received and opened, with Valdez Construction having the lowest bid at \$2,576,000.

At the April 24, 2024 board meeting, the Commissioners approved total project cost up to \$3,200,000. Mr. Brockmann asked for total project cost approval up to \$3,600,000 and authorization to move forward with signing the General Contractor Agreement. A motion was made, seconded, and unanimously carried out to approve up to \$3,600,000 for the District Office Remodel and permitted Mr. Brockmann to move forward with signing the General Contractor Agreement.

### **Bereavement Program Update:**

Ms. Ruth and Ms. Avry presented an update about the retooling and relaunch of the District's grief support services for children, youth, and families in Skagit County. Rooted:Grieving and Growing Together!, previously called "The Landing", is a program based on the Dougy Center model for peer grief support and priniciples of grief-informed services. Peer grief support groups for youth aged 6-18 and their caregivers wil be offered in a supportive environment with trained staff and volunteers. The program is hosting an open house on Tuesday, September 17 from 5:30pm to 7:30pm at the Hearthwood House.
