Active Living Update:

Mr. Pearson presented an update about the different programs that Active Living pillar oversees. Trek for Treasure, which has been gaining popularity through the years, had more than 350 teams and over 1,000 participants this past summer. The Fitness Center, which offers 33 classes a week, currently has more than 300 active members per month. With the return of instructor Lynne McNett, yoga classes have begun again at total capacity. Skagit Natural Rx is an instructor-led nature walk series for seniors or families with young children; Skagit Trail Builders has more than 50 volunteers that focus on designing, building and advocating for trails in Skagit County Parks.
